

# Who Has a Claim on the Assets?

### **U.S.** Confiscation Action

#### NATURE OF THE ACTION

This is an action in rem to forfeit approximately \$300 1. million in assets; and any property traceable thereto, involved in an international conspiracy to launder corrupt payments made to GOVERNMENT OFFICIAL A, a relative of the President of Uzbekistan and a government official at all times relevant to the facts alleged. This action seeks forfeiture of property located in Belgium, Ireland, and Luxembourg that was derived from violations of U.S. law pursuant to 18 U.S.C. § 981(a)(1)(C), and property involved in a money laundering offense in violation of 18 U.S.C. §§ 1956 and 1957 pursuant to 18 U.S.C. § 981(a)(1)(A).
